

Guar Daily Fundamental Report

3rd January, 2013

Domestic Fundamentals:

- Guar seed and guar gum prices noticed mixed tone on Wednesday.
- Farmers are bringing less produce to the market amid cold conditions in parts of north –west India.
- There is not much demand in the market around current levels.
- According to sources, around 3000 -4000 bags of new crop are arriving in mandis of Madhya Pradesh.
- Arrivals in various mandis improved slightly compared to previous day and are reported to be around 60000 -65000 bags in the country.
- Lack of stocks in the ready market lent some support to the market.
- According to trade sources, good export demand is expected by mid –January.
- In the overseas market demand is less amid Christmas and New Year holidays.
- According to a field survey conducted by Agriwatch team in three major guar producing states, output in Rajasthan is expected to be around 14 -16 lakh metric tonnes, in Haryana around 4 lakh metric tonnes and in Gujarat around 2.5 lakh metric tonnes.
- Small quantities of the guar seed crop is expected in the states of Andhra Pradesh and Madhya Pradesh.
- According to industry sources, export demand is likely to be lower by 30 percent in the current season compared to previous season.
- In the month of November 2012, exports of guar gum (split and powder) were reported to be 15312 metric tonnes according to IBIS.

Outlook: Prices are likely to notice sideways to weak tone in the near –term.

Guar seed March 2012 Contract and Guar gum March 2012 Contract:

FMC has stopped trading in all guar seed and guar gum futures contracts effective March 28, 2012.
