

Guar Daily Fundamental Report

12th January, 2013

Domestic Fundamentals:

- Guar seed and guar gum prices noticed recovery on Friday except slight weakness in Jodhpur and Nagaur markets.
- Buying interest around lower levels lend support to the market.
- Lower output estimates during this season added to the positive tone of the market.
- Arrivals in the country is reported to be around 60000 bags.
- According to trade sources around 300 -400 quintals of guar seed output is expected in Madhya Pradesh.
- Arrivals are expected to increase by next week.
- Currently there is more demand for guar gum split from China according to trade sources.
- In Andhra Pradesh, around 800 -900 quintals of guar seed crop is expected during this season
- There is not much export demand around current levels.
- According to the US industry data, last year, the oilfield services sector in the US alone used as much as 500,000 million tonnes of guar powder, a four-fold jump from the 2006 level.
- According to APEDA, exports of guar gum during the current year starting April till September increased by 13% to 3.19 lakh metric tonnes compared to same period previous year.
- In the month of December 2012, exports of guar gum (split, powder and meal) were reported to be 23860 metric tonnes according to IBIS.

Outlook: Prices are likely to notice steady to firm tone in the near –term.

Futures Market:

Guar seed March 2012 Contract and Guar gum March 2012 Contract:

FMC has stopped trading in all guar seed and guar gum futures contracts effective March 28, 2012.
