

Daily Sugar & Gur Fundamental Report

23rd January, 2013

Sugar & Gur Domestic & International Fundamentals

- Steady sentiments recorded in key sugar spot markets on Tuesday.
- Refined white sugar from Pakistan quoted at between \$505 to \$535 per ton. While millers are fetching Indian white sugar premium at between \$30 to \$35 per ton to LIFFE March contract.
- Brazilian raw sugar premium is trading at a discount of 0.3 cents a pound to the March contract sugar prices on ICE futures which was 0.5 cents a pound last week.
- China's sugar imports declined by 45% in December 2012 compared to last year same period. China imported 268362 tons of sugar in December 2012. In total, China imported 3.7 million tons of sugar starting from Jan to Dec 2012, which is 28.35% higher compared to last year. Major exporting countries of sugar to China are Brazil, Thailand and Cuba as reported.
- Gur prices declined today owing to higher arrivals in the market compared to prior day.
- Good demand of UP gur has been witnessed from Haryana, Punjab and Rajasthan confirmed by lower pace of gur stored in the cold storages compared to last couple of weeks.
- Around 313000 bags of gur stored in Cold storages in Muzaffar nagar region which are 4000 bags higher compared
 to last year. Out of total gur stock, 129000 bags of chaku gur, 55000 bags of Rascut and 99000 bags of Papdi
 stored in Cold storages as reported.

Outlook

Couple of good news like Extension of non-levy sugar quota and rumors of increase in sugar import duty help the sugar prices to rebound in spot markets during the week. It seems the prices reverse its bearish trend to neutral in the coming week.
