

### ❖ Soy meal Prices Remained Steady. FAS Steady.

- ✓ The soy meal exports remain weak owing to the demand shift followed by attractive price offer by South America.
- ✓ Global protein meal consumption is projected to increase 3.6 percent in 2011/12 by USDA. Protein meal consumption is projected to increase 7.8 percent in China, accounting for 54 percent of global protein consumption gains. This may boost India's oilmeal exports this season
- ✓ India continues to export the meal to it's neighboring countries over logistics and freight advantages.
- ✓ Global soybean exports are projected at 98.7 million tons, up 2.8 percent from 2010/11. China soybean imports are projected at 58 million tons, up 3.5 million from 2010/11- USDA.
- ✓ Global soybean production is projected to increase less than 1 percent to 263.3 million tons. The Argentina crop is projected at 53 million tons, up 3.5 million from 2010/11 crop based on a higher harvested area and yields. The Brazil soybean crop is projected at 72.5 million tons, down 0.5 million from the projected record 2010/11 crop - USDA.

- ✓ India exported about 2288 MT of GN meal in Apr 2011 compared to nil export in the corresponding period last year. The demand is expected to rise in May, as per trade sources. The GN Cake prices are likely to remain steady to weak in near to medium term on steady demand.

- ✓ As per latest release by Solvent Extractors' Association of India, the export data of mustard seed DOC for the month of Apr 2010 is reported to 1.42 lakh tonnes compared to 1.17 lakh tonnes in the corresponding period of the previous year.
- ✓ In May Indian is expected to export about 1.5 lakh tones in view of improved crushing as reported by the market sources.
