

Oilseed Daily Fact Sheet

May 24, 2011

Oilseeds Domestic Fundamentals:

Oilseeds price eased on higher supplies and weak international vegoil market. However, expected demand in the vegetable oils followed by auspicious period for marriages will push up the oilseeds price.

Oilseeds International Fundamental:

A temporary reduction of Chinese imports enforced a decline in world exports of soybeans by 1.9 Mn T from last year to 28.4 Mn T in Jan/April 2011.

Outlook:

The domestic oilseeds prices are likely to improve followed by expected demand in edible oils.
