

Wheat Domestic Fundamentals:

- Wheat cash and future market remained depressed on higher supply amid lower demand despite declining arrivals.
- Stake holders in future market released their position on bearish tone.
- Procurement may cross 26 MMT.U.P. and M.P. may contribute more in weeks ahead. Arrivals continue to flow in these market.

Wheat International Fundamental:

- US wheat futures finished mixed as rising US dollar weighs on nearby CBOT wheat. Worries about tightening supplies of high-quality grain due to unfavorable weather in US and Europe help support deferred contracts and other markets.
- US ending stock may exceed from trade expectation and supply concern has decreased to some extent..

Outlook:

Prices of wheat is likely to be under pressure on higher stock, better supply prospects and doubt over opening up export. Export on commercial basis is unlikely despite better procurement. Surplus stock with lower demand will weigh on the wheat market in short term.
