Oilseeds Domestic Fundamentals:

Oilseeds prices firmed up supported by buying support in cash market coupled with higher international vegoil market. However, no aggressive buying reported in seeds. Besides, delayed soybean plantings in US remained supportive to the prices.

Oilseeds International Fundamental:

The overall US soybean planting progress, week ending May 22, 2011, is reported at 41 per cent, well below the fiveyear average of 51%. A temporary reduction of Chinese imports enforced a decline in world exports of soybeans by 1.9 Mn T from last year to 28.4 Mn T in Jan/April 2011.

Outlook:

The domestic oilseeds prices are likely to improve followed by delayed plantings in US.
