

Wheat Domestic Fundamentals:

- Prices of wheat in cash and future market remained subdued on higher supply side supported by the possibilities of non opening up export immediately.
- India will not allow any wheat or rice exports from government stocks, despite ample supplies and bumper production this year.

Wheat International Fundamental:

- CBOT wheat futures closed sharply higher, with MGEX reaching a nearly 3-year high on rising concerns about rains delaying planting and dryer span in EU.
- Excessive rains are just the latest problem for wheat growers as the southern Plains and Western Europe are struggling with drought.

Outlook: Domestic

- World wheat market is expected to move up on rough weather condition in EU and excessive rains in U.S. The IGC has slashed its forecast for the 2011/12 global wheat crop by 5 million tonnes to 667 million. Planting gets delayed in US.
