

**Oilseeds Domestic Fundamentals:**

Soybean prices featured weak trend while mustard seed prices noticed steady tone in cash market. Weak demand in the soybean from crushers and steady demand in the mustard seed from millers and stockists was witnessed in the domestic oilseeds market.

**Oilseeds International Fundamental:**

The overall US soybean planting progress is reported at 41 per cent, well below the five-year average of 51%. South American soybean stocks likely to rise 2.2 Mn T by Sept 1, 2011, contrary to earlier expectations of a decline.

**Outlook:**

The domestic oilseeds prices are likely to improve followed by delayed soybean plantings in US.
