

**Pulses Domestic Fundamentals:**

- Good demand for chana is reported in most of the markets but since stockists have maintained adequate stock level during current year, therefore it might put cap on rising chana prices in near term.
- Marginal improvement is recorded for new moong and this has supported its prices in most of markets. Additionally, steep decline in moong prices also encouraged buyers to offload some quantity.
- Arrival of chana has once again improved in MP as higher chana prices have encouraged farmers to liquidate their stock.

**Pulses International Fundamental:**

- Canada has witnessed record peas exports during 2009-10 but demand from India has reduced during past few weeks due to huge disparity and this might put cap on rising international peas prices in near term.
- Stock of lentils in Canada till March 31, 2011 is reported at 1.025 million tonnes on farms and 95000 tonnes with processing plants.

**Outlook:** Prices of all the pulses are expected to remain range bound with weak bias.
