Cotton Domestic Fundamentals:

- Cotton prices remained mixed on Thursday with Kadi ending in the green, Abohar and Muktsar ending the green and Amravati remaining steady.
- Informal Group of Ministers are likely to meet on June 2 to take a decision on the issue of increasing the limit of cotton exports from the current 5.5 million bales for the current season.
- The Confederation of Indian Textile Industry (CITI) added that the export of 55 lakh bales earlier has created an artificial cotton shortage in India.
- Trade sources added that if export cap is not raised then India could see surplus of stocks this year.
- The Indian government said that Cotton has been sown in 9.5 lakh hectares as compared to 8.11 lakh hectares last year and no incidence of insect, pest and disease has been reported by the States.

Cotton International Fundamentals:

- U.S cotton futures remained firm higher on concerns that severe drought conditions in the U.S and China will slash output.
- Markets also moved higher after USDA said that approximately 73% of U.S. cotton crops were planted as of May 29th 2011, down from 77% a year earlier.

Outlook:

- In the short term, cotton prices may trade weak on higher acreage anticipations this year.
- Cotton futures may rebound on bad weather conditions in U.S may cause damage.
- In the long term price trend may depend on global production in U.S and India and demand from China.
