Technical Commentary:

Candlestick formation reveals sellers participation in the markets. Prices closed below 9 and 18-day EMA's thus supporting the bearish momentum in the short term. MACD is moving up in the negative region and hints at a decline in bearish momentum. RSI is moving down in the neutral region and supports the bearish sentiments in the futures market. Kapas futures are likely to trade with a weak bias.



Strategy: Participants may sell on rebounds.
