### Technical Commentary:

Candlestick formation reveals bullish sentiments. Prices closed below 9 and 18-day EMA's thus supporting the bearish momentum in the short term. MACD is flat in the negative region and hints at a decline in bearish momentum. RSI is moving up in the neutral region and supports the bullish momentum in the futures market. Kapas futures are likely to trade with a weak bias.



**Strategy:** Participants may sell on rebounds.
