## **Technical Commentary:**

Candlestick formation reveals indecision in the markets. Prices closed below 9 and 18-day EMA's thus supporting the bearish momentum in the short term. MACD is flat in the negative region and hints at a decline in bearish momentum. RSI is flat in the neutral region and is supporting the steady sentiments. Kapas futures are likely to trade with a weak bias.



Strategy: Participants may sell on rebounds.
