

Wheat Domestic Fundamentals:

- Higher arrivals, stocks and lower demand are weighing on wheat market fundamentals .Govt. is not ready to allow export from its bulging foodgrains stocks under compulsion of securing foods to the poor under food security bill and from fear of inflation that has been haunting the govt.
- Animal feed industries have started buying wheat as corn (maize) prices are higher.
- Wheat is being loaded for South India(Pune and Hyderabad) from Rajasthan and M.P. @ Rs 1270 and Rs1310-20 delivery basis.

Wheat International Fundamental:

- US wheat futures ends lower on spillover pressure from the steep fall in corn. Both grains are used for livestock feed.
- The drop in crude oil added pressure, as it was largely responsible for corn's slide. Additional selling was linked to the advancing US harvest. Weather conditions "should allow a fairly quick finish" in Oklahoma and Texas.
