

Wheat Domestic Fundamentals:

- Wheat market throughout the country is under extreme pressure during this week and it may continue further with additional 5 million T allocations to the poor.
- Besides under food security bill, likely to be presented in parliament in August, will enhance supply and it would have direct bearings on market sentiments in months ahead.
- India's Food Security Bill will add 1.1 trillion rupees (\$24.55 billion) to the government's annual subsidy bill.

Wheat International Fundamental:

- US wheat futures ended down as harvest advances in the Northern Hemisphere, bringing fresh supplies in from the fields. Kansas, the top U.S. winter-wheat growing state, saw another day of great harvest weather.
- That means Kansas farmers are continuing to make rapid progress on the 2011 wheat crop.
- Harvesting starts in Russia, supply likely to increase in mid-July.

Outlook: Domestic

- Pressure on wheat market will continue on expectation of higher supply backed by additional allocations of foodgrains for the poor.
- However, feed industries demand at lower level is expected to lent support cash market despite bearish outlook as maize prices are comparatively higher.
