

## Wheat Domestic Fundamentals:

- Mixed trend featured in cash and future wheat market today on various factors. Govt. intends to export through private trade. However, there are confusions over quantity and possible subsidy on wheat export. Export parity turns negative as international market saw a hefty fall in last two weeks.
- Market seems to be in wait and watch mood and direction will clear only after govt.'s stance.
- Wheat is being loaded from Gujarat to Kerela (Coimbatore, Kottam)@1370 and the trade is done at the margin of hardly Rs 250 per ton .Brokers are sourcing wheat @1060 per qtl.

## Wheat International Fundamental:

- Upward revisions to production forecasts in India and China may offset a further cut to the EU crop projection and a lower figure for the US.
- US wheat futures finish mostly higher as the market rebound from heavy losses.
- The forecast of global wheat output by IGC is boosted by 3 million T to 666 million T.

• World wheat stocks are expected to decline to 185m. tons(189m.)due to rising demand.

## **Outlook: Domestic:**

• Wheat market is expected to inch up on rising possibility of export despite disparity on seasonal factors. However one sided rally is unlikely due to higher availability of wheat in the market. Decision on export is awaited.
