

Wheat Domestic Fundamentals:

- Wheat cash and future market remained stable to weak on weak clue from national and international market. Supply side in domestic market is expected to be sufficient to cater the need of current and medium term demands.
- Govt. may enhance supply in domestic market through all possible routes to rein prices. Some discount for bulk and small traders is expected from govt.'s side as offtake from godowns has been comparatively lower.
- Govt. has to create storage space for paddy crop that is expected from October. Export chances through private channel have dried up and available stock has to be consumed in domestic market before arrival starts from paddy crop.
- Wheat stock as on 1st August pegged at 358.75 lakh T in central pool, higher than required buffer norm of 171 lakh T and 30 lakh T.

Wheat International Fundamental:

- World market is likely to remain bearish for short term on increased production forecast by IGC. IGC has pegged world wheat production at 674 million tonnes, almost 80 million tonnes higher than previous estimates.

Outlook: Domestic:

- Wheat prices are likely to be directed by govt. policy and allocation mechanism and price. Overall sentiment is bearish.
