

Wheat Domestic Fundamentals:

- Cash wheat market continued to rule under pressure with dwindling demand from south India and bulk buyers. Sluggish trading activities are likely to continue three- four days due to continuous holidays.
- Higher stock, lower offtake and lost export opportunity are weighing on the market. Govt.'s
 intention to curb inflation and augment supply in the market will continue to restrict market
 momentum for upper side.

Wheat International Fundamental:

- IGC has pegged world wheat production at 674 million tonnes, almost 80 million tonnes higher than previous estimates.
- CBOT wheat futures finished higher on increasing concerns over output. Wheat production in the northern Plains may decrease. Worries about a smaller-than-expected spring-wheat crop drove prices higher.
- Argentina says rains help key 2011/12 wheat area. Wheat, corn premiums steady; buyers on sidelines.

Outlook: Domestic:

Wheat prices are likely to be directed by govt. policy and allocation mechanism and price.
 Overall sentiment seems bearish.
