

Wheat Domestic Fundamentals:

- Steady to firm trend continued to rule the cash wheat market on expectation of allowing export.
 Govt.'s godowns are laden with hefty wheat and rice stock. Arrivals from new paddy crop are hardly one month away.
- So pressure is building up to consume wheat through export and decision is likely soon.
 Quantity for non basmati rice export may be increased to two million tonnes while one to two million tonnes wheat export may be allowed.

Wheat International Fundamental:

- IGC has pegged world wheat production at 674 million tonnes, almost 80 million tonnes higher than previous estimates.
- Markets got a boost from equities and a rally in corn.
- · Recent upswing has prompted technical buying.
- Australia sells 35,000 T high-protein wheat to Thailand

Outlook: Domestic:

• Wheat prices are likely to be directed by govt. policy and allocation mechanism. Export decision if taken may support wheat market. However, uptrend momentum might be restricted on record stock and disparity in the international market.
