

Pulses Domestic Fundamentals:

- Mostly steady to firm trend witnessed in cash pulses markets.
- Renewed demand for chana in Delhi, Mumbai and in some markets of MP (Indore) supported the prices despite low supply in these markets.
- As per the latest data release by the Andhra Pradesh Agriculture Department, the sown area under Kharif pulses as of August 30th ,2011 is down by 21 % to 6.45 lakh hectare as compared to the 8.17 lakh hectares corresponding the normal season. While sowing area of this period is down by almost 35% as against the last year's 9.86 lakh hectares.
- Tur has been sown in 3.94, Urad 0.66 and Moong 1.76 lakh hectares respectively as against the last year's sown area of 6.30, 0.81 and 2.63 lakh hectares.
- Latest updates from Rajasthan Agriculture Department, Moong has been sown in 1023.1, urad 162.7, chaula 143.2 and arhar 20.5 thousand hectares in Rajasthan respectively as against the last year's sown area of 1050,128,122 and 21 thousand hectares.
- And the latest release from Maharashtra Agriculture Department on August 30th, 2011,, Moong has been sown in 3932.42,urad 3313.09 and tur 11889.97 hundred hectares respectively as against the last year's sown area of 6118.76,4982.39 and 13689 hundred hectares.

Pulses International Fundamental:

- As per the Saskatchewan Agriculture's weekly crop report, producers of this province of Canada made excellent harvesting progress during the period August 23 to 29, 2011. Last week 21 % of the 2011 crop is harvested.
- As per the Canadian Grain Commission the visible pea stock are 225,100 MT, which is 15,100 above from the previous year.

Outlook: Demand for pulses is expected to remain good in coming day following forthcoming festivities which may support the prices in days to come.
