

Wheat Domestic Fundamentals:

- Prices Weak conditions prevailed at the wholesale grains market during the week as wheat traded lower due to reduced offtake. Reduced offtake by flour mills and stockists against adequate stocks position mainly led to a fall in wheat dara and milling grade prices.
- In view of the Onam season, the Central Government has allotted 54,000 tonnes of rice at the rate of Rs 11.85 and 27,000 tonnes of wheat at the rate of Rs 8.45 to Kerala.
- A meeting of the empowered group of ministers (EGoM) on food scheduled for Tuesday, has been postponed. According to the source, the meeting which was supposed to discuss wheat exports, as one of the agendas, was likely to be held next week.
- Wheat International Fundamental:
- An Israeli private buyer has issued a tender to purchase 42,000 tonnes of feed wheat.
- Russian wheat prices kept rising in the European part of Russia.
- The FOB Black Sea price for ordinary milling wheat with 11.5 percent protein content rose to \$295 per tonne from \$290.
- World market is likely to remain bearish for short term on increased production forecast by IGC.IGC has pegged world wheat production at 677 MT

Outlook: Domestic:

• Wheat prices are likely to remain subdued for short and medium term on higher supply side.
