

Wheat Domestic Fundamentals:

- Wheat market remains steady to weak despite export demand from B'desh. Sources say that neighbouring country B, desh will be a major buyer for Indian wheat and maximum approved export quantity may be shipped into it.
- At least seven to eight firms are interested in Indian wheat and they want supply in next 4 to 5 months. Indian exporters are offering wheat at around \$290-295 per tone including cost and freight via Chittagong port. Indian competitor Russia is offering wheat @ \$315 and the difference of \$20 to 25 is very attractive for B.desh buyers at present.

Wheat International Fundamental:

- U.S. wheat futures ended mixed, with CBOT closing mostly lower on pressure from tumbling corn prices. Widespread fund liquidation of grains, particularly corn, weighed on the market. Weekly export sales were unexceptional, as the US struggles to find buyers amid ample Black Sea supplies.
- World production is raised by 3m. tons, to 677m.(674m.). Total world wheat consumption • has been revised up to 678 m. tons (657m.) The global carryover is expected to be broadly unchanged placed at 191m.
