

Wheat Domestic Fundamentals:

- With unsupportive market fundamental wheat cash market could not sustain at higher level. Diminishing export parity with lower international prices and FCI decision to provide discount for bulk and small users through OMSS weigh on prices.
- Prices in all major markets decreased by Rs 30 to Rs 50 per qtl. in last two-three days. Loading for export purpose has come down with declining prices. Traders /brokers and exporters are waiting for stabilizing the market.

Wheat International Fundamental:

- US wheat futures finished at a 6-week low, pulling back from early gains on increasing jitters about poor demand. Export sales have been weak recently as Russian wheat is lower-priced than US wheat on the global market. Egypt, the world's top buyer, issued a tender for wheat and will likely continue to buy from Russia. Concerns about the shaky global economy add to worries about commodity demand.
- World production is raised by 3m. tons, to 677m.(674m.). Total world wheat consumption has been revised up to 678 m. tons (657m.) The global carryover is expected to be broadly unchanged placed at 191m.

Outlook: Domestic:

• Wheat prices are likely to remain steady to weak on increased demands.
