

Pulses Domestic Fundamentals:

- Mostly weak tone witnessed in major cash markets of pulses as a result of lack luster trade activities.
- Commencement of new crop arrival for urad and moong is weighing on domestic prices.
- In Rajasthan, during Wednesday's trade arrivals of 40,000 bags of moong are reported whereas on • Tuesday's 75,000 bags are reported in the state.
- Tuesday's trade arrivals of 75000 bags are reported in the state.
- As per the latest report from Karnataka Agriculture Department on September, 19th, sown area under Kharif 2011 pulses is as: tur has been sown in 7,53,057& urad 85,641 and moong 2,73,377 hectares.
- Significant decline is recorded in C&F quotes of urad FAQ from Burma but despite of this, importers • are still finding disparity at current levels.

Pulses International Fundamental:

- Killing frosts has reported in Saskatchewan State of Canada. As per the latest reports of Saskatchewan • Agriculture only 28% of chick peas have been harvested and frost has caused damage to the Chickpea crop.
- The harvesting of peas and lentils are almost finished and has therefore less effect from the frost •

Outlook: Chana prices are expected to decline on weak demand at higher levels while new crop arrivals of urad and moong are keeping pressure on the prices.
