

### Wheat Domestic Fundamentals:

- Wheat cash market continued to rule under pressure following sharp decline in the demand for wheat products and exporters unwillingness to buy even at lower prices.
- Lower prices in international market weighs on physical markets.
- Higher carry in stock in world market and aggressive sale through black sea reason at competitive prices have discouraged Indian exporters.
- Demand in domestic market is expected to improve in the second week of Oct.
- Wheat International Fundamental:
- US wheat futures slumped on a bearish USDA report and spillover pressure from corn.
  Grains and oilseeds fell generally on the report, which showed greater-than-expected Sept. 1 supplies for corn and wheat.
- The report implied that both corn and wheat feed demand fell off sharply at higher price levels, but some traders are skeptical that both could drop given that the number of livestock was high in the quarter.

### **Outlook: Domestic:**

• Wheat prices are likely to trade stable at current level. Ample supply from govt. side is expected to reign the market.
