# **Cotton Domestic Fundamentals:**

Cotton prices remained mixed amid buying activity seen from exporters. Sources say that export demand will come after the Deepavali festival from China as Chinese current year's import quota which is scheduled to expire in December. Millers remained absent due to disparity in yarn at current levels. However, in the next 3-4 days arrivals will be lower through the Deepavali festival. Cotton may fall after the Deepavali festival on higher global output and lower demand.

### **Cotton Domestic Futures Market:**

NCDEX Kapas April 2012 contract finished weak at against previous close price. Rise in open interest amidst falling prices suggest that the new money is coming through the short sellers and a downtrend is in place. Volume of trade remains unchanged at previous day's level of 2,476.

# **Cotton International Fundamentals**

Cotton futures finished higher on Monday on investor buying. The December cotton contract on ICE Futures US rose 0.84 cent to close at 97.94 cents per lb. Market participants are still worried that demand from top consumer China will remain weak and the pace of US cotton exports will stay slow. China Cotton Association said that China's cotton output this year will likely reach 7.28 million metric tons, up 9.3% from a year earlier. Meanwhile, Punjab Agriculture Department in Pakistan has advised growers to start picking cotton after 40 to 50 percent bolls are matured. So this may restrict uptrend.

# **Outlook: Domestic and International**

In the short term, domestic cotton prices move range bound in the next 3-4 days on Deepavali festivals. In the long run prices will come down on higher production estimates and weak demand.

U.S markets may trade range bound to weak due to better U.S crop condition.
