

Oilseeds Domestic Fundamentals:

Soybean and RM seed prices featured losses on sluggish buying activity on Wednesday. The market participants are view in that the soybean supply pressure is yet to witness the market. However, as per sources a large volume of the soybean produce in Madhya Pradesh is reportedly gone to warehouses of the farmers. This may slow down the supplies and may support the prices at higher levels. In Rajasthan transport facility and labour shortage has once again hit the major soybean markets like Baran, Bhawani and Kota mandis which has effected in the off-take in the markets. ADM, Ruchi, Poddar and Shiv Edibles remained the active buyers in soybean. No major overseas deal in soy meal reported.

The RM seed planting is underway and it is complete in Rajasthan by 1869.5 thousand hectares compared to 1721 thousand hectares in the corresponding period last year. However, it behind 5 year average of 2813 thousand hectares.

International Oilseeds Fundamental:

The US soybean harvest is negatively hit in some parts due to rainfall in Eastern Midwest. This remains a bullish factor.

Outlook:

We expect the oilseeds prices to gain in near-term on seasonal oil and meal demand.
