Oilseeds Domestic Fundamentals:

Arrivals from Rajasthan markets were reported slightly higher than the previous day and stood at 100000 lakh bags. Big players like Ruchi, Adani and ADM shown active buying in major Rajasthan markets in today's trading session. Moreover arrivals from Maharashtra stay steady and total arrival stood at 2.0 lakh bags. We expect soybean likely to trade with a positive bias as suppliers hold their stocks which might support the prices in near term. (Pl. refer last page for Raj. trade activity)

International Oilseeds Fundamental:

As per Argentina's crop progress report, Farmers have planted 44 percent (8.3 million ha.) of the record 19 million hectares forecasted for soy this season up by 2% as compared to previous year. Sowing has mostly been completed in Marcos Juarez (in the southeast part of major farming province Cordoba) is likely to complete in a coming week. USDA confirms that private exporter sells 124,500 tons of soy beans to china for 2011-12. It was the second large sale to China earlier 420,000 tons were exported for this week.

Outlook:

We expect soybean and RM seed prices to gain in near-term on expected rise in seasonal demand in edible oils and lower supplies in the oilseeds.
