

Pulses Domestic Fundamentals:

- Today's trading session most of the markets continued to rule steady.
- As per the trade sources, rabi pulses sowing is in full pace in Bundelkhand region (Uttar Pradesh). The tur standing crop is in good condition in the state.
- In Jaipur market, huge arrival of sub-standard quality of moong supports the price. The bold quality was traded at Rs.4500/qtl while the sub-standard quality moong was traded at Rs. 2800/Qtl.
- Comfortable stocks coupled with lack luster buying interest from traders even are currently weighing on masoor prices.
- Due to fresh arrivals of vegetables in markets, we expect pulses likely to trade with steady to weak bias in near term.

Pulses International Fundamental:

- Thin trading activity and uncertainty about the lentil's new crop quality leads to dull export trading activity.
- Field pea's market remained firm during the last week. Moreover, field pea available stocks this year is up by 14800MT to 282300 MT as compared to corresponding period of last year.

Outlook: Sideways movements in pulses prices are expected in term due to dull demand.
