Pulses Domestic Fundamentals:

- Mostly steady to firm tone witnessed during today's trading session.
- Fresh buying interest for processed dal supports the prices.

AGRIWATCH

- Sources revealed that good quality chickpea C&F quoted at USD 630-365/MT for January shipments. While, the rain affected chickpea of Western Australia quoted at around USD 605/MT.
- As on rabi sowing front, 62,000 hectares is been planted under gram in Bihar in comparison of 52000 hectares in previous year.
- Moreover, as per latest release on 7th Dec. from Andhra Agricultural Department, sown area dwindle by 3.12% to 8.07 lakh ha. in comparison of last year's 8.33 lakh ha.
- Chana sowing in state also decline by 5.68% to 4.98 lakh ha.
- On crop progress front, no rainfall from last two months in major producing districts of pulses in Karnataka would be going to affect the yield on later stage.

Pulses International Fundamental:

- Field peas production in Australia is forecast to be down by 31% or 133000 tonnes to 301000 tonnes on lower area planted and lower yield.
- South Australia the leading field pea producing area of Australia may also witness decline in production by 35.34% to 150000 tonnes while marginal rise in production is expected in Western Australia.
- On field peas export front, a downfall of 9.37% in average prices during the quarter Jul-Sep 2011 noticed on sluggish demand from importing countries with lower prices in all markets.

Outlook: Pulses demand from processors front may support the prices along with fresh buying interest in masoor at lower levels.
