

Wheat Domestic Fundamentals:

- Wheat cash and future market traded lower on unsupportive market fundamentals. Stockists are in a wait and watch mood and market seems to be in uncertain phase.
- Stockists may be active after Diwali and till then market is expected to stabilize and will sense further move in the market. Besides, govt's release and price strategy will play a vital role in weeks ahead in domestic markets.

Wheat International Fundamental:

- US wheat futures ended mixed, with Chicago wheat bouncing in a recovery from last week's sharp declines. Signs of stability in neighboring grain futures attracted buying, but Minneapolis spring wheat futures were unable to sustain any price strength, as traders adjusted prices to catch up with the losses seen in other markets late last week. However, spring wheat futures did move significantly off initial lows, pick up the buying that buoyed other grain markets.
- Russia has won a series of tenders run by Egyptian state grain buyer GASC, the latest one
 jointly with Kazakhstan. Russian grain was bought at \$250-\$252.50 per tonne, Kazakh grain
 at \$254 at the tender.

Outlook: Domestic market: Wheat prices are likely to stabilize at current level. Fresh demand is expected from second week of Oct.
