

Wheat Domestic Fundamentals:

- Wheat market remained almost flat and no major development was reported from any markets. Fresh activities are expected to start after diwali. Decision on MSP is awaited. Market expects prices to stabilize at current level. Hike in MSP will support market.
- Wheat loading from Kota to Mysore continues@ 1345-1350 per qtl on delivered basis. Wheat loading from Gujarat to south India is picking up.

Wheat International Fundamental:

- CBOT wheat futures finished little changed as grain markets pared gains ahead of the close. Profit-taking and a setback in corn prices pressured the markets. Wheat lacks strong export demand for support as Russia continues to undercut US grain prices on the world market.
- It's been tough to find buyers. CBOT December wheat ends up 1 1/4c at \$6.32/bushel as KCBT December slips 2c to \$7.23 and MGEX December rises 1 3/4c to \$9.19 1/4.
- Global wheat supplies for 2011/12 are projected 5.4 million tons higher with larger beginning stocks in Australia.

Outlook: Domestic market:

India's wheat futures and cash markets are expected to trade steady to firm next week on higher demand and picking up fresh interstate trade. Expected hike in MSP may lent support to bearish wheat market to some extent.
