

Guar Domestic Fundamentals:

Mostly firm sentiment featured in key Guar spot markets today. As per trade sources, restricted supply of guar in domestic market (as new crop arrivals have come to an end) and limited stocks by stockists at around 8 - 10 lakh bags which is not sufficient enough to fulfill the requirement may further push the guar prices to gain in coming days.

Fairly widespread rainfall may continue northeast and adjoining east India. Scattered rainfall activity is likely over central and northwest India. However, subdued rainfall activity may continue over south interior peninsula.

Outlook:

Both guar seed and guar gum prices are expected to remain range bound in coming days on lower stocks, higher exports and normal progress of monsoon so far. Stockists are offloaded their stocks at higher price level which may exert pressure on guar prices in coming days.
