

#### **Fundamentals:**

Markets remained positive in major trading centers on Wednesday. Sentiments remained firm as trade source revealed that rainfall over the last 2-3 days have caused a water logging problem in the sowing areas of Rajasthan. Sources also added that if sowing areas do not dry up in the next few days we could some occurrences of rot on plants. However everything would depend on the weather conditions in the next week to 10 days. However sentiments continue that production will be around 2 crore bags this year due to good rains during the initial sowing period which may lead to higher yield. However area sown this year is lower at 31.218 lakh hectares compared to 35.034 lakh hectares in previous year.

## **Weather Update:**

Guar crop in vegetative stage in the key growing region Rajasthan, Haryana & Gujarat and prevailing weather favours good crop growth and better yields. Widespread rains would occur over Gujarat and northwest India in the next 48 hours.

#### **Outlook:**

Guar prices are expected to remain range bound with slight firmness with reports of water logging which could lead to rot in the plants. Weather in coming 7-12 days will remain the key for deciding the actual price movement of both guar seed and guar gum.
