

### **Fundamentals:**

Markets remained mixed in major trading centers on Thursday. Sentiments remained firm as trade source revealed that rainfall over the last 2-3 days have caused a water logging problem on the fields and may cause a rot disease which may cause losses. Sources also added that if sowing areas need sunshine in the next few days for a good crop this year. So the weather conditions in the next week to 10 days become a major factor for the crop and prices trend. Trade sources also revealed that Ruchi Soya holds a majority of stocks and are not willing to release the stock just yet.

## **Weather Update:**

Guar crop in vegetative stage in the key growing region Rajasthan, Haryana & Gujarat and prevailing weather favours good crop growth and better yields. However, widespread rains would occur over Gujarat and northwest India in the next 48 hours may cause crop damage.

#### **Outlook:**

Guar prices are expected to remain range bound with slight firmness with reports of water logging which could lead to rot in the plants. Markets also moved higher supported by reports of lower stocks. Weather in coming 7-12 days will remain the key for deciding the actual price movement of both guar seed and guar gum.
