

### Fundamentals:

Sentiments remained steady to firm as domestic and export demand has remained firm over the last few weeks. Prices also remained firm as production is expected to be lower for 2011-12 at 11.36 lakh tonnes from 14.88 lakh tonnes in the previous year. However trade sources say that production could be at 20 lakh tonnes and farmers are also predicting 17-18 lakh tonnes as area have increased. However, good yield will depend on the weather conditions in the next few weeks. So weather should be monitored over the sowing areas. Guar is expected to arrive in the market in about 1 month. Exporters and millers say that export demand will continue to the end of this year.

### Weather Update:

Guar crop in vegetative stage in the key growing region (Rajasthan) and prevailing weather may be favourable for crop growth. According to IMD, dry weather conditions would persist over Rajasthan, Gujarat and Haryana during the next week.

### Outlook:

Guar prices are expected to remain range bound to firm on lower production estimates from the state agriculture department of Rajasthan. Weather in coming 15 days will remain the key for deciding the actual price movement of both guar seed and guar gum.
