

Fundamentals:

Guar prices continued to show mixed trend on firm domestic and export demand. Weaker rupee at 51.3530 against the dollar may aid exports as well. Harvesting is in full swing in North and West of Rajasthan. Harvesting and post harvesting is in full swing in Haryana. Crop is in early harvest stage in Gujarat and harvest will start in the last week of November. New crop arrivals (all India basis) totaled at 65,000-70,000 bags (1 bag =100Kg) unchanged against previous day's arrival. Millers are active buyers in the market. Currently, out of the total arrivals 100% is gathered up by the millers. Sources revealed that millers are buying from markets directly and are buying from 4000-4500 range. The quality of the stock coming into the market is of 5% black variety where only 5% of moisture is seen in the fresh stock. This will continue to support the prices at 4000 levels and we can expect markets not to break the mentioned level.

Outlook:

Both guar seed and guar gum prices are expected to remain range bound to firm on firm demand and lack of arrivals in coming days. Lower production estimate, lower carry-in stocks may support the prices in medium to long term.

Futures Market:

Falling open interest and rising prices for **NCDEX Guarseed December contract** is indicating that the short sellers are covering their positions and the upmove will not be sustained unless new buyers enter the market. Rise in open interest along with prices for **NCDEX Guargum December contract** indicate that an uptrend is in place and is likely to be sustained.
