Soy meal traded with a steady tone due to thin trading activities. Soy meal, FOR Kandla, quotes stood steady at Rs18300-18400/MT on Saturday. Bearish WASDE report might weigh on the soy meal prices in near term. However, fair demand from international market would restrict excessive losses in coming days.
