

Soy Meal Fundamentals:

Soy meal, FOR – Kandla was quoted steady consecutive third day at Rs 42,000/MT. A vessel is waiting for berth at Kandla port to load an unknown quantity of soy meal for exports. Oil World has estimated world production of soya meal to decline by at least 1.5 Mn T or 3.4% from a year earlier in Oct/Dec 2012, enforcing a further decline in stocks as well as a cutback in world consumption.
