

Soy Meal Fundamentals:

Soy meal, FOR – Kandla was quoted steady consecutive fourth day at Rs 42,000/MT in the absence of fresh demand and lower export sales. No major activity featured in the soy meal at Indian ports. Oil World has estimated world production of soya meal to decline by at least 1.5 Mn T or 3.4% from a year earlier in Oct/Dec 2012, enforcing a further decline in stocks as well as a cutback in world consumption.
