

Domestic Fundamentals:

- Edible oil basket traded with a steady to weak tone in major cash markets in tandem with bearish international markets on Thursday.
- Palm oil prices stood weak in major markets tracking bearish cues from futures market and low demand weigh on the
 prices. However, sharp downside is likely to be cushioned by the bullish global soy and palm complex.
- G/N oil prices further soften at Rajkot market on lackluster buying interest and stock limit by Gujarat government. Limited fresh buying and dull demand for G/N oil may weigh on the prices in days ahead Rajkot Based trader.
- Primary trend remains firm on bullish domestic as well as international edible oil complex fundamentals. However, market may witness correction at higher levels in days ahead.

International Market Fundamentals:

- CPO at BMD futures ended lower in today's trading session on account of slow global economic growth and profit booking at higher levels.
- USDA cut its forecast for sunflower oil exports from Ukraine in the current agricultural year (September 2011 to August 2012) by 6.5%compared to its January forecast to 2.9 million tonnes.
- As per MPOB latest report, Malaysian palm oil ending stock for March drop 5 percent to 1,959,240 tons from a revised 2,062,065 tons in February.

Outlook:

We expect edible oil prices to be in range due to bullish global oilseed fundamentals. However, poor off take may curb excessive gains.
