

Wheat Domestic Fundamentals:

- Wheat cash market traded mixed on indecision in the market. Market fundamentals remain weak on higher production estimates and govt.'s intention to move grains from surplus to deficit states. Arrivals from new crop are expected to increase from mid of March and it will increase supply. However, wheat is expected to trade in the range of Rs 1200 to 1250 per qtl. for short term and with the beginning of procurement it may move towards MSP level. Procurement on MSP will start from 15th March in M.P. and Gujarat and in other states, from 1st April.
- Wheat procurement by Centre for the Rabi marketing season 2012-13 is likely to surge by more than 12.5% to the peak 31.8-million tonnes (mt). In 2011, Centre had procured 28.34-million tonnes for subsidized sales under the public distribution system. No major damage from any regions has been reported as of now.

Wheat International Fundamental:

 Wheat prices remain under pressure on higher production estimate from IGC and higher supply estimates by USDA. However, demand for feed wheat will increase but lower maize prices restrict wheat to move up. Wheat fundamentals are weak and pressure will continue to dominate the world wheat market.

Domestic market outlook:

Wheat market is expected to trade weak on bearish outlook.
