

Fundamentals:

Overall Guar Prices remained firm on Wednesday supported by strong miller's demand. However, a dip in export demand is witnessed today in the market. Hence, traders expect possibility of correction in the market ahead of next trading sessions. Moreover, millers are buying guar seed further to fulfill their immediate gum requirement. Overall arrivals of India stood slightly up at 62000 lakh bags against previous day arrivals at 60000 lakh bags. In the current scenario, only U.S is the major buyer with limited quantity. China is still waiting for prices to come down.

Futures Market:

Guarseed January 2012 Contract: Falling open interest and rising prices is indicating that the short sellers are covering their positions.

Guargum January 2012 Contract: Falling open interest and rising prices indicates short covering in market for short term.

Outlook:

We expect a short correction in Guar market due to slow down export demand.
