Domestic Fundamentals:-

Overall both Guar seed and Guar gum advanced besides Jodhpur loose price which closed down. NCDEX also ended up due to short covering activities running in the market. In sport market, demand of both side millers as well as exporters are subdued despite lower stocks in the market, which may further pulled down guar seed price. Traders are in view of bearish trend further. In the current scenario, only stockists are bringing their stocks in the market as farmers have no more stocks. Millers have stopped processing gum now due to disparity as said by traders. We expect market may trade in range bound in between 11000 to 12500 during upcoming trading sessions.

Futures Market:

Guarseed February 2012 Contract and Guargum February 2012 Contract: Falling open interest and rising prices are indicating that short sellers are covering their short positions in the market.

Outlook:

We expect market may trade in range bound during this week ahead in Guar complex in expectation of lower export and millers demand.
