

Guar Daily Fundamental Report

29th December, 2012

Domestic Fundamentals:

- Guar seed and guar gum prices noticed recovery on Friday except slight weakness in Sirsa and Bhiwani markets.
- Arrivals are slightly less in various mandis.
- Some of the mandis in Gujarat remain closed following local holiday.
- Mills are not performing to their full capacity amid lack of good export demand.
- Arrivals in the country are reported to be around 55000 -60000 bags.
- Farmers are bringing the crop in the market according to their requirement.
- In the current season sowing was delayed and arrival is likely to pick up in the coming days.
- Farmers did a morcha on 23rd December 2012 in Jodhpur for re –launching of guar complex futures. Government is not likely to re –launch guar complex futures as on date.
- Some of the farmers have paid higher price of seed around Rs.600/kg for sowing purpose.
- In the month of November 2012, exports of guar gum (split and powder) were reported to be 15312 metric tonnes according to IBIS.
- According to the first advance estimates of Rajasthan agricultural department, guar production in the current season is estimated at 16.57 lakh metric tonnes compared to 12.5 lakh metric tonnes in the previous season.
- According to the first advance estimates of Haryana agricultural department, guar production in the current season is estimated at 3.75 lakh metric tonnes compared to 2.0 lakh metric tonnes in the previous season.

Outlook: Prices are likely to notice steady to weak tone in the near -term.

Guar seed March 2012 Contract and Guar gum March 2012 Contract:

FMC has stopped trading in all guar seed and guar gum futures contracts effective March 28, 2012.
