


Potato Fundamentals:


- Wholesale prices in major markets decreased by Rs. 50-100/Qtl yesterday due to ongoing harvesting
 of fresh potato across the country.
- Uttar Pradesh is expected to produce 14-15 million tonnes, compared with 13-13.5 million tonnes last year. West Bengal's production is estimated at 9.5 million tonnes, against 8.5 million tonnes last year.
- There is ongoing unrest among the cold store owners of west Bengal as the cold store rent is much lower than actual cost incurred for storing potato in the season. Cold store rent in West Bengal is Rs. 101/Qtl where as in UP it is in the range of Rs. 150-170/Qtl.
- Some of cold stores in west Bengal are still not opened due to this lower rent. This might impact the
 prices during harvesting and farmers may have to sell their produce in distress.
