


#### **Potato Fundamentals:**


- In West Bengal, prices have gone up in Burdwan and Tarkeshwar by Rs 20-40/quintal because traders from U.P, Chhattisgarh and Punjab are buying potatoes as of low prices compared to other parts of country.
- According to trade sources in West Bengal, State government has decided to procure Rs 27 crore
  potatoes from farmers in order to help farmers as prices are low and farmers are not even able to get
  back cost of cultivation
- In Khandauli (U.P), approximately 20-25% of harvesting is completed. According to trade sources, productivity has increased by 10% compared to previous years.
- In Northeast, maximum retail price were in Shillong at Rs 3000/ quintal followed by Guwahati at Rs 1800/ quintal, whereas lowest prices were in Itanagar at Rs 800/ quintal.
