

## Daily Sugar & Gur Fundamental Report 25<sup>th</sup> February, 2013

### Sugar & Gur Domestic & International Fundamentals

- Sugar prices traded steady to weak in key sugar spot markets on Saturday. Dull demand kept the pressure on the sugar prices.
- Meanwhile, vessels are waiting to load around 132700 tons of raw sugar at Brazilian ports that is bound to India, according to Williams shipping agency. It is notable that Indian refiners mainly SRS already import more than 1 million tons of raw sugar from Brazil.
- Increasing sugar selling by millers and moderate sugar demand from upcountry buyers led the sugar prices steady in Kolhapur market as reported.
- Government has decided not to increase sugar import duty on both raw as well as white sugar for now. This news gives sellers a chance to made new short positions in NCDEX sugar futures
- Demand of sugar witnessed from Maharashtra towards MP and Raiasthan, However, Delhi market is getting sugar only from UP as reported.
- Gur prices declined today in Muzaffar nagar spot market despite of lower arrivals. Raining occurred in various regions of UP yesterday night make it difficult for gur manufacturers to bring the goods to the market.
- Total around 355101 bags of gur (40kg each) stored in cold storages till 18th February 2013 which are 335899 bags (40kg each) lower compared to last year same period. Out of total 355101 bags of gur, around 155000 bags of Chaku gur, 60000 bags of Rascut, 100000 bags of Papdi, and 1500 bags of Khurpa stored in the cold storages as reported.

Government decision not to increase sugar import duty increase the selling activities in the sugar markets. We expect prices are likely to fall from present level in the coming days.
