Domestic Fundamentals:

- Most of the edible oils featured steady to slightly weak tone tracking bearish cues from international palm oil market and cautious buying from wholesalers.
- Rapeseed oil featured weak tone owing to dull demand from wholesalers and stockists. As per sources, higher palm oil • products imports and lackluster buying interest weigh on the cash market. However, slow selling by the famers featured in the cash market, which may limits excessive losses in the coming days.
- Groundnut oil quoted lower at Rajkot market due to lackluster buying from repackers and adequate supplies hurts the . market sentiments. Groundnut oil quoted Rs 1170 per 10 Kg, down Rs 30 per 10 Kg from Friday.
- Refined soybean oil featured firm tone on renewed demand and dwindling soybean supplies. However, subdued demand for soy meal keeps check on the prices.
- Edible oil basket is expected to feature range bound movement in the days ahead. However, renewed demand ahead of wedding season which may support market sentiments.

International Market Fundamentals:

NCDEX Soy Refined Oil:

- Crude Palm Oil June contract at BMD ended lower to MYR 2281 per tons, down MYR 54 per tons from Friday in expectation of bearish Malaysian palm oil figures for April and profit booking.
- Indonesia cut its export tax for crude palm oil for May to 9 percent from 10.5 percent in April Indonesian Ministry. Malaysian palm oil products export for April 1-25 rose 2.7 percent to 10.8 lakh tons from 10.5 lakh tons in the March 1-25 period. Better buying witnessed from Indian and European buyers. While, Chinese imports were slightly lags on mo-m basis. India imports 173,999 tons of palm oil products in April 1-25 to 173,999 tons up 114.4 percent from same period of a last month - Societe Generale de Surveillance.
